Mouldkill X200

Mouldkill X200 has been developed to kill mould, fungi, algae and lichen in industrial and residential situations. By using a weaker solution and applying on a regular basis this product will ensure a permanently sterile surface.

DIRECTIONS

Refer to the table to select the mixing ratio most suited to the intended task. Apply using a garden spray pack or other suitable applicator to spread the product evenly over contaminated surfaces. For heavy infestation, such as concrete or clay tile roofing, allow approximately 30 days for the product to kill all debris. All debris should then be removed by low pressure waterblasting. A further coat at a mixing ratio specified under "steriliser" will provide good long-term protection of that surface if it is to remain unpainted.

In all other circumstances follow the mixing ratios and apply evenly over the contaminated surface to provide a surface that can either be left in its present state or the material can be removed by low pressure waterblasting to ensure a clean, bright surface.
