This product is supplied as a concentrate and should be thinned to a concentration appropriate for the intended task. Refer to the table below to select the most appropriate mixing ratio.

Apply the prepared solution by physically scrubbing onto the surface in a manner which will generate foam. When cleaning is complete remove **Corrodex Degreaser** and wash the cleaned surface down with fresh water.

Where there is heavy contamination of grease and fats it may be necessary to rinse with hot water and/or carry out the cleaning process twice to ensure that the surface has been thoroughly degreased.

After washing allow the surface to dry thoroughly before further preparation and painting as required.
